Gretchen Burns Bergman is the Executive Director and Co-Founder of A New PATH. She served as State Chairperson for Proposition 36, mandating treatment instead of incarceration for non-violent drug offenders. A native of San Diego, she is Owner/Director of Gretchen Productions, a Fashion Show Production Company, started in 1979. Her articles on treatment vs. incarceration have been published nationwide, and she has spoken before countless audiences on the topic of therapeutic justice for people with addictions. She has two grown sons who have struggled with addictive illness.

"As a parent, I know first-hand how pointless and dangerous it is to throw a drug-sick individual in prison, where he is treated like human storage, rather than giving him the services to recover, to make amends and heal wounds that he inflicted while living in the nightmare of addiction, so as to be able to give back to society."
